

**MEMORANDUM OF UNDERSTANDING**

This MEMORANDUM OF UNDERSTANDING (MOU) is made and entered into on 01<sup>st</sup> October 2022 BY AND BETWEEN:

ICAI Ranchi Branch situated at ICAI Bhawan, Dr Mukti Saran lane, Lalpur, Ranchi, hereinafter referred to as "**ICAI Ranchi Branch**" which term shall mean and include its Ranchi branch members, students & their dependent family members.

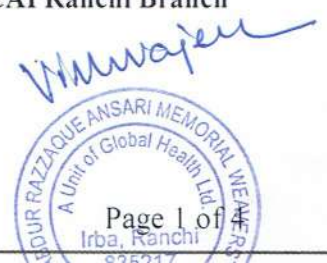
WHEREAS "**ICAI Ranchi Branch**" is interested in identifying and entering into a Memorandum of Understanding with **Medanta Abdur Razzaque Ansari Memorial Weaver's Hospital, Ranchi (A Unit of Global Health Ltd.)** for INPATIENT/OUTPATIENT/INVESTIGATIONS for its members, students & their dependent family members in accordance with their entitlement:

**THE MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:**

The "**Medanta Hospital Ranchi**", hereby undertakes to extend its Medical / Surgical facilities for complete **inpatient and outpatient** Medical / Surgical treatment including diagnosis, tests, investigations, prescription, dispensation of medicines etc., to the members, students, employees and their dependent family members of "**ICAI Ranchi Branch**"

**IDENTIFICATION:**

1. While availing OPD consultation, investigation and services in OPD, the concerned member, students, employees and dependent family member will produce **Identity card issued from ICAI, New Delhi** which contains Name of member and students.
2. While seeking admission to the hospital for **inpatient** treatment the concerned member, students, employees and dependent family member will produce **Referral Letter** which contains Name of member, students, relationship with member/students of ICAI Ranchi branch signed by the chairman of "**ICAI Ranchi Branch**"



**EMERGENCIES:**

1. In case of emergencies, the members, students and their dependents may be admitted by the hospital on production of Identity Card issued by "ICAI, New Delhi".

**Tariff & Charges:**

1. Medanta Hospital Ranchi has agreed to charge "ICAI Ranchi Branch" for the treatment of its members, students and their dependents as per prevailing Hospital Tariff.

**Patient Care Services & Priority:** Medanta Hospital Ranchi is committed to extend standard & quality patient care services at an affordable rates to member of ICAI Ranchi Branch, their dependent family member and students registered with ICAI Ranchi Branch. Medanta Hospital Ranchi would extend all possible priority to ICAI Ranchi Branch members and beneficiaries while rendering services to them in OPD & IPD care areas.

1. This Memorandum of Understanding is for a **period of one years** from **October 1st, 2022** subject to renewal by mutual agreement thereafter.
2. This agreement could be annulled by either party by giving **one month notice in writing**. However, all claims outstanding to be raised against the unit shall still be covered under the agreement till the claims get finally settled.


**OTHERS:**

1. Whenever there are general revisions in the rates to be applied because of inflation or in view of more sophisticated methods or because of making the procedures more equipment-intensive, the new rates shall apply under this agreement. However, the **““Medanta Hospital Ranchi”,”** shall give **30 days' clear notice before such rate revision is to be effective.**
